Q1. I am a South African or Botswanan national. I booked my travel to Ireland <u>before</u> 10 July 2024 and I am due to arrive in Ireland before 10 August 2024. Do I need a visa to come to Ireland?

Answer: As your travel plans fall within the transitional arrangements, you may travel to Ireland without a visa in this period. However, you must remember to bring evidence of your flight booking (made BEFORE 10 July 2024) so that you can present the information to your carrier, or to Irish Border Officials, if requested. The normal immigration rules that apply to non-nationals on seeking entry to the State will apply to any person availing of the transition arrangements.

Q2. I am a South African or Botswanan national and booked my flights for Ireland on 10 July 2024, i.e. the day the visa imposition came into effect. I plan to travel to Ireland before 10 August 2024. Do I need a visa to come to Ireland?

Answer: <u>Yes</u>. As you did not book your flight <u>before</u> 10 July 2024, you will need a visa to come to Ireland. Q3. I am a South African or Botswanan national. I booked my flights prior to 10 July 2024 and I intend to travel to Ireland on a date <u>after</u> 9 August 2024. Do I need a visa to come to Ireland?

Answer: <u>Yes</u>. The transitional arrangements only apply to customers who booked flights <u>before</u> 10 July and will travel to Ireland <u>before</u> 10 August 2024. As you will be arriving into Ireland after this date you will require a visa. Q4. I am a South African or Botswanan national. I have not made any flight or hotel booking in Ireland just yet, but I want to travel to Ireland during July/August 2024. Do I need a visa to come to Ireland?

Answer: Yes. The transitional arrangements only apply to customers who booked flights to Ireland before 10 July and are due to arrive in Ireland before 10 August 2024. Answer: <u>Yes</u>. The transitional arrangements only apply to customers who booked flights to Ireland <u>before</u> 10 July and are due to arrive in Ireland before 10 August 2024. Answer: If you hold a valid IRP card, then provided the IRP card is in date when you are travelling to Ireland, you <u>do not need a visa to come to Ireland</u>.

Q8. I am a Botswanan national. The transitional arrangements in the notice do not apply to me. How do I apply for an Irish visa?

Please note: No visa documents should be submitted either by post or in person to the Irish Embassy in Pretoria. All visa application documentation must be presented at a VAC. Q10. I am <u>not</u> a South African or Botswanan national, but I am living in South Africa or Botswana. Do I need a visa to come to Ireland?

Answer: The transitional arrangements mentioned in the notice only apply to South African or Botswanan nationals.
